Jim earned his Associates degree in Hotel, Motel, Restaurant and Club Management from Essex Community College and is also a certified Ping club fitter. His first golf related job was in outside services at the Elkridge Club when he was 15 years old, working under David Jones and Lance Poe, PGA.
