

PGA Deferred Comp Web Enrollment Directions

GET STARTED WITH THIS LINK

1. At first, you will see this screen with two options
 - **Enroll** - Clicking this button will start the enrollment process
 - **Learn More** - Clicking here will bring you to the program plans to provide you with more information regarding plan details and eligibility requirements
2. To begin the enrollment process click '**Enroll**', and you will be brought to the following screen:
 - This screen shows the pathway to complete the enrollment process, which includes 1) Terms & Conditions, 2) Account Details, and 3) Confirmation.
 - You will need your name as it appears on your driver's license, your mailing address, and social security number in order to complete the enrollment process.
 - To continue the enrollment process, click '**Continue**'
3. Next, you will be brought to the '**Terms & Conditions**' page.
 - This page outlines the Deferred Compensation program's terms and conditions
 - At the bottom of this page, you can click the link to the plan details if you would like to read additional information or reference at a later time
 - To continue the enrollment process, you will click '**Accept Terms**'
4. The next portion of the enrollment process is the '**Term Agreement**' page
 - By clicking the box, you are acknowledging and agreeing to the terms provided
 - A link to the plan details can be found at the bottom of the terms for the member's reference
 - In order to continue the enrollment process, you will check the box and then click '**Agree & Continue**'
5. The next page is the '**Account Details**' page, where you will be able to input your information.
 - You are required to input your legal name, address, and social security number in order to submit their enrollment.
6. Once complete, click '**Submit**' and you will see one of the following screens:
 - **You're Enrolled:** You have successfully completed your enrollment and have now been enrolled in the program.

You will also receive this email notifying you of your successful enrollment in the deferred compensation program.
